**Subject: Notice to take-down videos and statements in relation to IQOption Ltd ("IQOption").**

We, IQOPTION LTD a company incorporated and registered in the St. Vincent and the Grenadines with company registration number 24840 IBC 2018 and having its registered address at Hinds Buildings, Kingstown, St. Vincent and the Grenadines (hereinafter "IQOption"), write to you in relation to the statements posted by you, without limitation, in relation to IQOption, the management of IQOption as well in relation to Mr. Dmitrii Zaretskii directly. The offending statements and videos posted by you, without limitation are, are accessible via the respective URLs: <https://dmitriizaretskiiscam.my-free.website/> and [http://www.mediafire.com/file/i7w4qwiism8j64/iqoption\\_scam.mp4](http://www.mediafire.com/file/i7w4qwiism8j64/iqoption_scam.mp4) (collectively referred to as the "Offending Statements").

The Offending Statements include without limitation statements and allegations such as: "Dmitrii Zaretskii is an internet scammer/criminal!!! He stolen millions of dollars via his company (iqoption.com) from the profitable traders!!!", "Please download and check the full scam report how iqoption stolen 24100 GBP from me", "Dmitrii Zaretskii (iqoption owner) and Anton Rabinovich Stolen from me 24100 GBP !!!".

The actions taken by you and the information disclosed by you through these Offending Statements are (i) untrue and are likely to cause serious harm and damage to the reputation of IQOption and are therefore maliciously false, defamatory and slanderous, (ii) in **breach of clause 7(2)(D) (Confidentiality) of the agreement dated 02.09.2019 entered into by and between you and IQOption in relation to the terms and conditions for the provision of IQOption's services**, and (iii) in breach of the settlement agreement entered by and between you and IQOption dated 09.10.2018.

We hereby give you actual knowledge of the above and request that you act expeditiously to remove the Offending Statements and any other videos or statements published by you (either directly or indirectly) which defame and/or slander IQOption its employees, management business partners and undertake not to publish via any means any further videos or statements with similar allegations and/or information referred to in the Offending Statements.

If you remove the Offending Statements and or other material, to our satisfaction and stop blackmailing our company within 24 hours and provide us with a notice thereof, we will take no further action against you in respect of this matter.

- If you fail to proceed as instructed above, we reserve the right to issue proceedings against you seeking relief for defamation, slander and breach of contract.
- If proceedings become necessary (which may be issued and served without further notice to you), the remedies that may be available to IQOption include an injunction restraining further publication of the Offending Statement [pending trial], damages, legal costs and interest, **with the lowest amount of our claim estimated to be in at least of USD500.00,00.**
